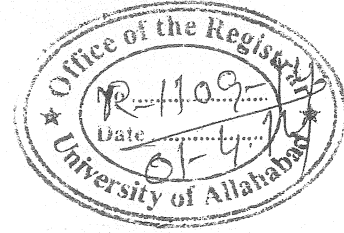
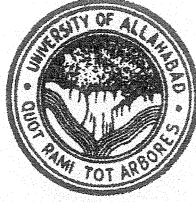

Agenda No. 01/18 To discuss the process of the admissions 2014-15.

Resolution No.01/18 Resolved that the recommendations made by the Admission Committee in its meeting held on 29-03-2014 vide **Appendix-1, 2 & 3** be approved with the following modifications :-

- i. Amendment to para 9 of the Admission Regulations regarding the admission of the wards of the employees and teachers under the 5% supernumerary seats as proposed by the Sub-Committee consisting of Prof. Rakesh Khanna, Dean, Law and Prof. B.P. Singh, Professor of Law, as annexed (**Appendix-2**) be approved with the condition if in case seats remain vacant in a course in the Unit/ Sub Unit, these will be filled by the wards of the employees of other Units/Sub Units.
- ii. The suggestion for a reasonable increase in the amount being paid currently @ of Rs. 100/- per candidate to the constituent colleges/institutes towards miscellaneous expenses was made and **it was further resolved** that the Advisory Committee for the Admission Test will consider and make a suitable recommendation for increase in the amount.
- iii. While accepting the recommendations made by the Advisory Committee of the Athletic Association of the University, **it was also resolved that** rules framed by the Athletic Association should not be at variance with the Regulations of the University Grants Commission.

The meeting ended with a vote of thanks to the Chair.
