The Chairman welcomed all the members of Academic Council. Thereafter, the agenda item were taken-up.

**Agenda No.01/26**

**To consider the matters relating to Semester System, CBCS, Academic working in Schools, Students Feedback Form and other Academic regulations, reorganization Initiatives in the Departments & Centers of the University.**

**Resolution No.01/26**

The Academic Calendar for the academic session (2016-17) of the University was presented to the members of Academic Council after long deliberations by the members of the Council the report presented was approved for adoption with minor changes relating to local holidays.

There shall be contract appointment for teachers for the Departments facing shortage of teachers in the faculties. This shall be applicable from the next academic session and the entire interview that shall be conducted for the purpose of contractual appointment shall have a Vice-Chancellor nominee. The roadmap for contractual appointments shall be :-

- (i) All the contractual appointment shall get completed by 15-07-2016.
- (ii) All the Heads of Departments shall ensure for providing of vacant position in time to the Registrar's Office and no applications for requirements for the academic session shall be entertained thereafter.
- (iii) These contractual appointments shall be for a period of two years.
- (iv) The guidelines issued by UGC Regulation 2010 and amendments made thereafter shall be applicable for eligibility and other selection related criteria for these contractual appointments.

**The following changes shall also take effect from next session:-**

1. The Postgraduate examinations shall be conducted in house only.
2. The Academic Council decided that no External Examiners other than for Ph.D. and M. Phil. Shall be permitted from the next academic session (2016-17).
3. The Vice-Chancellor proposed that the academic restructuring be done on the basis of School of Studies rather than keeping it as a Faculty. These changes shall help in organizing similar natured Departments/Centers/Institutes under a single Schools of Study which shall finish of the confusions related to Departments relation to the Faculties. Presently it was observed that some of the Courses of Study of similar nature exist in more than one Departments / Centers / Institutes. After a detailed discussion 12 schools were approved and it was decided that they be submitted to the Vice-chancellor for further action in the matter relating to amendment to the Statute, 14 of the First Statutes, under Section 28, of the University of Allahabad Act, 2005.

Remedial classes shall be started for English Languages for all the students enrolled in the University by the present Department of English and Modern European Languages so that the students passing out of the University have better opportunity for employment outside.

There shall also be class for Computer Awareness by the Computer Centre in the Department of Electronics & Communication, A.U.

Students shall also have facility to improve their general health and fitness and necessary assistance shall be provided by the Department of Physical Education.

There shall be monitoring of the students attendance by a Cell that shall be constituted for this purpose by the Vice-Chancellor and the minimum attendance required for a students shall be 75% during the semester.

A Student Feedback Form for assessment as per the MHRD/NAAC Guidelines shall also be introduced from the next academic session. A format of the Student Feedback Form was circulated among the member of the Council during the meeting for adoption and it was unanimously agreed by the Council members.

It was unanimously resolved to allow Ewing Christian College to function as per UGC guidelines for Autonomous Colleges & consequently to introduce new courses from session 2016-17 including PG courses.

No Publication Grant shall be given by the University, for publication.

The Council decided that there shall be regular revision of courses for which classed are conducted by the University and Colleges.

The Council also adopted CBCS and Semester from the next academic session.

The **Centre of Globalization & Development Studies**, shall from the next academic session (2016-17), be know as **Centre of Development Studies**, and it shall have only Post-Graduate classes and Research.

From the next Academic Council meeting it was decided that Agenda items shall be sent on Media (e-mail) to members of the Academic Council well in advance to save paper that is being used for printing of Academic Council agenda.

The Vice-Chancellor informed that he has already constituted a Committee to relook into the Ordinances of the University and suggest amendments wherever needed under the Chairmanship of Prof. R.K. Singh, Department of English. A.U.

The Vice-Chancellor informed that the CBCS shall be introduced from the next academic session as per the direction of UGC.

The letter of UGC, D.O. No. F.10-6/20111 (PS) Misc. dated 06-07-2015 of Prof. Jaspal S. Sandhu, Secretary, UGC, New Delhi regarding guiding and supervising of the research by the regularly appointed teacher was recorded and notified for adoption by the University vide letter no. 05/R/70/2016 dated 25-01-2016.

The Vice-Chancellor also informed that all the eligible Faculty of the University who can undertake Research Students can take up to eight (8) Research Scholars under them.

After thorough discussion, **it was resolved that** five days week in the teaching and offices of the Central University of Allahabad for improving efficiency in administration, the total working hours will remain same i.e. 36 hours in a week keeping Office timing from 9.00 A.M. to 5.00 P.M. be approved from next academic session i.e. 2016-17. The Lunch Break in the 5 days week for the University shall be from 01:00 P.M. to 01:45 P.M. In addition to above the academic session shall run as per the Academic Calendar as passed by the Academic Council, the work load for teaching shall be as per UGC Regulation 2010 or as amended from time to time, the present working hour shall not be less than 40 hours (forty hours) per paper per semester. However, this does not restrict the Teachers/Researchers/Students for utilizing the Library/Lab/Research facility etc. beyond the five days. The Department shall strictly adhere to the teaching Research by involving every faculty of the Department and observing the Academic Calendar, Semester System and ensuring CBCS. The Department shall also ensure recruitment of contractual appointment of teachers in advance preparation of Semester time table and other related matters for the new academic session.
