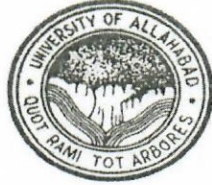

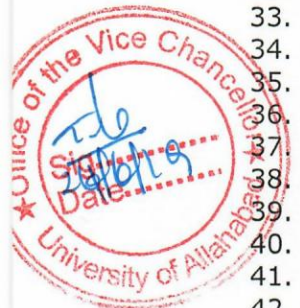

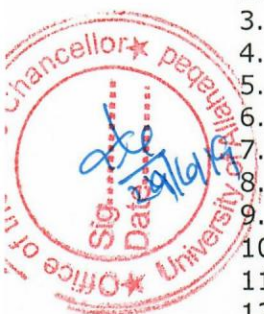

Resolution No.10/36

The Chairman informed the members that the Students Union had failed to discharge its assigned functions. During the current session there were, one after the other, three murders arising out of Students Union related rivalries. The so called Student Leaders had illegally and unauthorizedly occupied a number of rooms in the University Hostels. The University had been receiving a plethora of complaints from the Contractors, shopkeepers and other service providers in and around the University campuses and the general public against acts of extortions and vandalism perpetrated by the so called Student Leaders. Every then and now there used to be a serious law and order problem. Maintenance of peace had become a big challenge and it would continue to be so unless an appropriate corrective measure was taken.

It was in that background that the recommendations of 'Lyngdoh Committee' with regard to the Students Council in place of Students Union by direct voting by the students of University of Allahabad was considered by the members of Academic Council. After taking the gravity of situation under consideration **it was unanimously resolved that with effect from the session 2019-2020 there would be Students Council in place of Students Union by direct voting by the students of University of Allahabad. It was also resolved that on the same pattern there would also be Students Councils in the Constituent Colleges of the University.** It was **further resolved** to constitute the following Committee to work out, as early as possible, the modalities for the constitution of the Students Council in the University as well as in the Constituent Colleges:

Resolution No.12/36

The Chairman informed the Academic Council that the University of Allahabad had been facing a very serious handicap in the form of its territorial jurisdiction limited to a radius of only sixteen kilometers from the Convocation Hall and as such it had lost many opportunities of expansion, creation of new facilities and establishment of new Departments and Faculties, Schools and Centers. As the only way out to overcome such serious challenges **it was unanimously resolved to do away with the limit on the territorial jurisdiction of the University by proposing an appropriate amendment in the sub-section (1) of section 8 of the University of Allahabad Act, 2005 (Act No. 26 of 2005 passed by the Parliament), in the following manner :**

It was **further resolved** to recommend the above proposed amendment in sub-section (1) of section 8 of the University of Allahabad Act, 2005 to the Executive Council for further necessary action at their end.
