Note:-The Hon'ble High Court in exercise of inherent powers under Section 482 Cr. P.C., allowed the instant application and quashed the charge sheet dated 08.10.2016 and the entire criminal proceedings of Case No.689 of 2013 (S.T. No.127 of 2016), Police Station Colonelganj, District-Allahabad pending in the Court of Special Judge, S.C./S.T. Act, so far it relates to the present applicant.

The relevant excerpts of the observations are hereunder quoted verbatim:

- 76. This is a case where there is pure abuse of process of law where the complainant, just to wreak the personal vengeance against the Head of Department, had tried to implicate him and his colleagues by filing false and frivolous cases. Whenever the Seniors/Head of Department/Professors asked her to teach properly and to take classes regularly, she would file a complaint against them. This is not one of the first case which happened. The complainant, who is a well educated lady, knows the provisions of law very well and she had been abusing the provisions of law for personal gain. The complaint filed by the complainant was nothing but a pure abuse of process of law.
- 77. Because of the filing of frivolous cases, the reputation and public image of the applicant and his colleagues, who are Professors and people with high morals and reputation, had been tarnished. They had to run from pillar to post, from Police Station to Court to save themselves. Evidently, this was false and frivolous case filed against the applicant only to wreak personal vengeance. Such kind of vexatious proceedings should not be allowed to continue and if anybody engages in doing so, such activities have to be curbed down. This is a perfect case where exemplary cost should be imposed on the complainant/O.P. no.2. The loss of reputation, public image and the financial loss caused to the applicant are far much more, but as a token a cost of Rs.5 lacs is imposed on O.P. no.2 for abusing the process of law by filing frivolous cases only for personal vengeance and personal gains. This amount should be given to the applicant forthwith after making deduction from the salary of O.P. no.2 as well as other benefits given by her employer.
- 78. Prima facie, on bare perusal of the FIR, the statements of O.P. no.2 under Sections 161 and 164 Cr. P.C., no offence for which the applicant has been charged, is made out.
- 79. This is a case where the Court if does not interferes and exercises the inherent powers under Section 482 Cr. P.C., it will fail in its duty. In exercise of inherent powers under Section 482 Cr.P.C., the instant application is allowed and charge sheet dated 08.10.2016 and the entire criminal proceedings of Case No.689 of 2013 (S.T. No.127 of 2016), Police Station, Colonelganj, District-Allahabad pending in the Court of Special Judge, S.C./S.T. Act, so far it relates to the present applicant, are hereby quashed.

80. With the aforesaid observations, the instant application stands allowed.

In the above case the Hon'ble Supreme Court on 13-05-2024 (Petitions for Special Leave to Appeal (Crl) No(s): 6318/2024) has upheld the judgment of the Hon'ble High Court of Judicature at Allahabad.

Resolution No.12/83 The Executive Council was apprised of order of the High Court of Allahabad, reserved on 13-02-2024, delivered on 23.02.2024 in the Application u/s 482 Cr. P.C. no.38781 of 2016. The members of the Executive Council expressed anguish over the trauma which was faced by the three senior professors of the Economics Department due to the false complaints filed against them by Dr. Deepshikha Sonkar which were proved to be motivated, false and baseless. It was also noted that already a disciplinary proceeding is under process against Dr. Deepshikha Sonkar vide EC resolution no.04/78 dated 15-09-2023. The members observed that all teachers must maintain absolute integrity and devotion to duty and must refrain from engaging in any kind of falsehood. Taking a serious note of the act of filling such false complaints which tarnished the reputation and public image of the three professor and brought disrepute to the name of the University, it was unanimously resolved that a show cause notice must be served on Dr. Deepshikha Sonkar asking her to explain her outrageous conduct of filing false and frivolous cases/complaints. The written reply to the said notice must be presented before the Executive Council in its next meeting wherein after considering her reply a suitable decision shall be taken. In case Dr. Deepshikha Sonkar fails to reply, it shall be assumed that she doesn't have any satisfactory explanation and the Council shall processed in the prescribed manner. The Registrar is authorized to serve the show cause notice (giving a time of 21 days for the reply) to Dr. Deepshikha Sonkar.

Therefore some modifications were placed before the consideration of recommended the Council which Academic modification to the Executive Council with minor changes. If it is also passed in Executive Council then it will be placed before the Visitor. It is made clear that any modification in Statute can Ca Chancallor abad

Replies of 17 audit paragraphs have been prepared and are under process of submission to local unit of C&AG of India. Thus, 51 audit paragraphs have been processed so far.

In addition to above, satisfactory replies to two audit objection i.e. on Hindu Hostel and on pay fixation of a non-faculty member raised during current audit inspection have also been prepared and submitted to audit party.

Efforts are in-progress to prepare replies of remaining 88 audit paragraphs.

- 2) Prof. J. A. Ansari (Faculty) Rs. 34,260.00 (on 12.01.2024)
- 3) Mr. K. K. Dwivedi (Clerk) Rs. 1,09,632.00 (on 17.01.2024)

EC members unanimously resolved that: -

- 1. A written warning be issued to Prof. J. A. Ansari and Shri K. K. Dwivedi, Junior Office Assistant, University of Allahabad.
- 2. The case of Prof. R.S. Yadav, a retired faculty member may be referred to Ministry of Education for advice on release of pensionary benefits and other administrative action against Prof. R. S. Yadav, keeping in view the unauthorized withdrawal of the money from the accounts of the University of Allahabad.
- 3. Prof. J. A. Ansari be debarred from taking any administrative charge in future.
- 4. Withholding of Five cumulative annual increments of Shri K.K. Dwivedi.
