MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN UNIVERSITY OF ALLAHABAD AND MOTILAL NEHRU MEDICAL COLLEGE ALLAHABAD PRAYAGRAJ

This MoU is entered into on August 20, 2024 by University of Allahabad (hereinafter called AU) situated at Prayagraj (U.P), India, a Central University.

And

Motilal Nehru Medical College Allahabad, Prayagraj, U.P. hereinafter called MLN Medical College situated at Prayagraj (U.P.)

The aforesaid institutions are hereinafter referred to individually as Institute and collectively as Institutions.

1. Objectives of the MoU

This MoU is aimed at creating collaborative academic research frame work in the areas of mutually beneficial academic endeavours and harnessing potential capabilities of both the Institutes in enriching the academics of students of AU and MLN Medical College.

- a) Development of joint education programmes
- b) Exchange of Faculty members and students as per mutually agreed duration (full time and part time) terms and conditions for academics.
- c) Joint or collaborative research projects and publications.
- d) Joint organization of technical meetings, international workshops, conferences, seminars, faculty development programs, symposia, etc.
- e) To encourage students of MLN Medical College to come for higher education and internship at AU and vice versa.
- f) Helping in increasing the placement of students and consultancy projects.

The MoU ia also aimed to promote horizontal and vertical integration of academic institution in the region and to promote resource sharing amongst academic fraternity for excellence in education as per the process of the NEP 2020.

2. Technical Areas of Collaboration

- a) To implement a Continuing Education Programme to improve quality of staff of MLN Medical College and AU through short-term/long-term certification courses.
 - b) To provide academic interaction through Special Lectures on topics of relevance to Industry, Skill India, Digital India, community development etc.
 - c) Organization of joint workshops/conferences and Personality/Professional Development Programmes for enhancement of knowledge and skills of Faculty, Staff and Students.
 - d) Offering of elective courses- Joint or individual at either or both institutions.
 - e) Joint supervision of PG and Ph.D. theses.
 - f) Joint International and National sponsored/Consultancy projects.
 - g) Offering courses on Credit Transfer basis.

3. Terms and Conditions

- a) This MoU may be amended, renewed and terminated by mutual written agreement of the institutions at any time.
- b) Either Institution shall have the right to terminate this MoU upon 60 days prior written notice to the other institution.

4. Confidentiality

- a) AU and MLN Medical College agree to hold in confidence all information/data designated by the institutions as being confidential which is obtained from either institute or created during the performance of the MoU and will not disclose the same to any third party without consent of the other institution.
- b) The above confidential clause under this MoU excludes the information/data possessed by either institution before entering into this MoU or independently developed and/or information already available through public domain.
- 5. Duration of MoU This MoU, unless extended by mutual written consent of the institutions, shall expire in FIVE years after the effective date specified in the opening paragraph. However, on review, the MoU shall be extended by mutual consent.

- 6. Coordination
- Both Institutions will designate persons who will have responsibility for co-ordination and implementation of this agreement.

7. Intellectual Property Rights

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutions.

8. Liabilties and Remuneration

Liabilities and Remuneration may be taken into consideration on case to case basis.

9. Signed in Duplicate

This MoU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the institutions, acting by their duly authorized officers, have cause this Memorandum of Understanding to be executed, effective as of the day and year first and year first above written.
