It has come to the notice of the Competent Authority that some of employees are indulging in unconstructive, unnecessary and unwarranted criticisms of various policy /administrative decisions etc. of the University of Allahabad & are tarnishing the image of the University by using Social media like Twitter, Facebook, Social networking groups like WhatsApp, etc. This has been viewed very seriously by the Authorities of the University.

It is hereby informed to all the faculty members, non-teaching staff, outsource staff and other persons associated directly and indirectly with the University that, in case, they have acted against the interest of the university and are trying to spoil the image / diminishing /damage the image of the University in any manner on Twitter, Facebook, Social networking groups whatsapp etc. In such circumstance, University will take action against such persons and this will also attract disciplinary action against him/her. This amount to gross misconduct and shall lead to serious disciplinary action against the person doing so, as per the directives of the Government of India and the University Act, Statutes and Ordinances.

Therefore, it is stressed and strongly recommended that the faculty members, non- teaching staff, outsource staff and other persons associated directly and indirectly with the University should refrain from giving any opinion in public in freewheeling public debate or posts on social media that may damage the image of the University.

This is issued with approval of the Competent Authority and comes in force immediately for strict compliance.
