**OFFICE ORDER**

It has come to the notice of Competent Authority that some of the AUCHS beneficiaries often approach the Medical Cell / Medical Consultant and Office of the Medical Officer for recommendation of their Medical claims, which are not in accordance with the AUCHS norms as the University is paying the admissible amount strictly in accordance with AUCHS as approved by the Executive Council and no deviation is entertained by the authority of the University.

In order to make the awareness among the AUCHS beneficiaries following points are brought to the notice of all concern:-

1. AUCHS (Allahabad University Central Health Scheme) is aligned with Central Government Health Scheme (CGHS) norms but it is not CGHS. Hospitals / Diagnostic Centers empanelled with CGHS need not to be part of AUCHS.
2. All the AUCHS beneficiaries are informed that they should avail medical facilities only from the empanelled hospitals / Diagnostic Centers at Prayagraj. The claim of treatment at non-empanelled Hospitals / Diagnostic Centers will not be considered by UoA, provided that the beneficiaries were not referred to that Hospital / Diagnostic Center by the Medical Officer of University.
3. AUCHS beneficiaries, if referred by Medical Officer of University, to non-empanelled Hospital / Diagnostic Center at Prayagraj or outside Prayagraj, the reimbursement of submitted Medical bills will be processed as per AUCHS norms at current CGHS rates.
